# Code of Conduct

1. Camper must be on time for all meetings, activities, and meals.
2. Camper needs to sleep in order to receive all that God has for them. Camper must sleep in their place, not with other student/leaders.
3. Camper must honor the established music, magazine and video game guidelines: Electronic Gadgets like: Radios CD/Mp3 Players, Cell Phones, Lasers, video games, etc., or anything else that would prevent you or others from receiving from God are not allowed.
4. In consideration of fellow campers, camper must shower daily and uphold clean personal hygiene.
5. Public display of affection is prohibited.
6. Fighting is prohibited.
7. Campers are not allowed to enter the dorm of the opposite sex at any time.
8. Pranks and/or destruction of property is strictly prohibited.
9. Theft is prohibited.
10. Camper is not allowed to possess or use tobacco, alcohol, illegal substances, fireworks, firearms, pocketknives, weapons, etc.

These actions will be confronted once and restriction of free time will be taken if actions are repeated.

## Codes of Conduct 5-7

These actions will result in one of the following ways, based on the seriousness of the action and at the Camp Director's discretion: restriction of free time, kitchen/bathroom duty, or MAY be sent home at the parent's time and expense, WITH NO REFUND.

## Codes of Conduct 8-10

These actions WILL result in your teen being sent home immediately at the parent's time and expense, WITH NO REFUND. It WILL be the responsibility of the parent to pick the student up from camp within a timely manner.

\* All consequences will be given at Camp Director's discretion and some actions may result in student forfeiting right to attend camp the following year.
